



Bike Box Lease Assumption of Risk and Release of Liability Agreement

This lease dated _____ is entered into between _____ of _____ ("LESSEE") on the one hand, and Cristin A. Reichmuth and Body and Mind Solutions ("LESSOR"), on the other, on the following terms and conditions:

1. In consideration of the rental fees of \$20.00 week / \$475.00 deposit, on two separate checks, the lessor will provide a bike box to the lessee on a rental basis.
2. The bike box will be available 2 (two) days minimum prior to the rental date and up to a maximum 4(four) days prior to the reservation date without further cost or obligation. Bike boxes can be available earlier at additional charge or by prior agreement between the lessor and lessee.
3. The bike box is to be returned to the lessor no more than 3 days after the date of the event.
4. The lessee will assume all responsibility, and any cost, of returning the bike box to the lessor.
5. The lessee will be responsible for any damage caused to the bike box by the lessee and/or other people or during the time the bike box is in the lessee's possession. If , in the opinion of the lessor, the bike box is returned damaged above normal wear and tear, a repair fee will be charged, equal to the amount of the repair. If the bike box is damaged beyond repair, in the opinion of the lessor, the lessor will charge the lessee the cost of the replacement value of bike box. That value is \$475.00. (____) **Initials of lessee confirming he/she understands these details.**
6. Late Fees: If the bike box is not returned to the lessor by the due date as indicated above, the lessor will charge the lessee a late fee of \$10.00 a day per bike box. If the bike box is not returned in reasonable condition within 10 business days, lessor will charge the lessee the replacement value of the bike box. That value is \$475.00. (____) **Initials of lessee confirming he/she understands these details.**
7. The bike box does not guarantee that the bikes will arrive and return from my travels in perfect condition. (____) **Initials of lessee confirming he/she understands these details.**
8. The lessor is not responsible for any damages done to any equipment or personal possessions of the lessee placed in the bike box. (____) **Initials of lessee confirming he/she understands these details.**
9. Bike boxes must be reserved. A \$20 fee will be charged upon reservation and will apply towards the bike box rental. A check in the amount of the rental and deposit are due upon rental. A \$20 charge will apply if the bike box is reserved and never picked up. There are no refunds if the bike box is not used during the duration the bike box is in the possession of the lessee.

I have read and understand the details of this agreement. I agree to the above terms and conditions and I agree to be responsible for the return of the bike box in good condition on or before the due date.
